DID YOU KNOW?

...That Ohio's Concealed-Weapons Law goes into effect as of April 8, 2004?

This means if you intend to carry a concealed weapon, you have to have completed the required training involved to do so! The training course being offered by **CWTC of Ohio, LLC**, fulfills the State of Ohio's requirements.

...That there a number of requirements that must be met before you can obtain or renew a license to carry a concealed handgun?

You must obtain and submit a completed application form to the Sheriff of the County in which you reside, or to the Sheriff in any County adjacent to the county in which you reside.

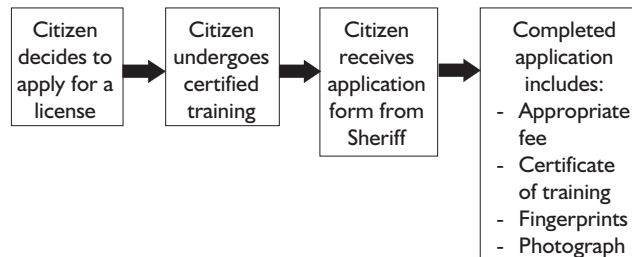
A non-refundable license fee in the amount prescribed by the Ohio Police Officer Training Council (OPOTC) – approximately \$45, is required.

A certificate of "Certification of Firearms Training" must be provided. Upon completion of the **CWTC of Ohio, LLC**, training course, you will be given the proper paperwork needed to fulfill this requirement.

In addition, you'll need to provide certification that you've read the pamphlet – *C.W.T.C. Supplies Pamphlets* – prepared by OPOTC and the Attorney General that reviews firearms, dispute resolution and the use of deadly force.

A set of fingerprints, either done by your Sheriff's Department (Electronic Fingerprint Reading Device) or by C.W.T.C. Using a standard fingerprint impression sheet is required to be on file.

Summary of the Application Process



THE REVISED CODE... DECODED

There are course requirements set forth by the "Revised Code" that must be met. They are as follows:

Each course, class, or program must include at least **12 hours** of training in the safe handling and use of a firearm that must include all of the following

- (1)** at least **10** hours of training on the following matters:
 - the ability to name, explain, and demonstrate the rules for safe handling of a handgun, and proper storage
 - practices for handguns and ammunition
 - the ability to demonstrate and explain how to handle ammunition in a safe manner
 - the ability to demonstrate the knowledge, skills, and attitude necessary to shoot a handgun in a safe manner
 - and gun handling training, and
- (2)** at least two (2) hours of training that consists of range time and live-fire training.
